

**THE COMMISSIONERS OF ST. MICHAELS
PUBLIC NOTICE**

The Commissioners of St. Michaels adopted Annexation Resolution No. 2017-03 during their regular monthly public meeting held on December 13, 2017. The Annexation Resolution is entitled:

AN ANNEXATION RESOLUTION PURSUANT TO SECTION 4-401, ET SEQ. OF THE LOCAL GOVERNMENT ARTICLE OF THE MARYLAND ANNOTATED CODE FOR THE PURPOSE OF ANNEXING NINE PARCELS OF REAL PROPERTY CONSISTING OF 2.692 ACRES OF LAND, MORE OR LESS, LOCATED IN THE SECOND ELECTION DISTRICT OF TALBOT COUNTY, MARYLAND, ALONG THE WESTERN BOUNDARY OF THE TOWN, AND BEING MORE PARTICULARLY DESCRIBED IN THE RESOLUTION; PROVIDING FOR THE TERMS OF SUCH ANNEXATION IN THE ANNEXATION PLAN AND AGREEMENT; AMENDING THE CHARTER OF THE TOWN OF ST. MICHAELS FOR THE PURPOSE OF INCLUDING THE ANNEXED PROPERTIES WITHIN THE LEGAL DESCRIPTIONS AND PLATS DEPICTING THE CORPORATE LIMITS OF THE TOWN OF ST. MICHAELS; AND GENERALLY RELATING TO THE ANNEXATION OF THE FOREGOING PROPERTIES TO THE TOWN OF ST. MICHAELS.

The properties to be annexed are more particularly described in Annexation Resolution No. 2017-03 and are shown on Talbot County Tax Map 200 as follows: Parcel 1679, Parcel 1688, Lots 38 and 39, Parcel 1689, Lots 40 and 41, Parcel 1690, Lots 42, 43, and 44, Parcel 1691, Lots 45 and 46, Parcel 1692, Lots 47 and 48, Parcel 1692A, Lots 49 and 50, Parcel 1694, Lots 51 and 52, and Parcel 1695, Lots 53 and 54.

The foregoing properties will be annexed into, and deemed part of the incorporated area of, the Town of St. Michaels, Maryland on January 30, 2018 unless a petition for referendum meeting the requirements of Md. Code Ann., Local Gov't §§ 4-408, 4-409, or 4-410 and addressed to the President of the Commissioners of St. Michaels and the Town Clerk/Manager is either delivered by hand or by certified mail, return receipt requested, and bearing a postmark from the U.S. Postal Service, to the Town Office, 300 Mill Street, St. Michaels, Maryland 21663 by 5:00 p.m. on January 29, 2018.

Copies of Annexation Resolution No. 2017-03 will be available to the public until January 29, 2018 at the Town Office during normal business hours.
