ORDINANCE NO. 491

AN ORDINANCE TO CHANGE THE SALARIES OF

THE COMMISSIONERS OF ST. MICHAELS

WHEREAS, the Commissioners of St. Michaels currently receive an annual salary of Two Thousand Dollars (\$2,000.00), which amount was established by Town Ordinance No. 239, adopted April 14, 1998, which superseded Ordinance No. 178, adopted September 8, 1987, which set the rate at \$500, which superceded Section 451 of the Charter of the Town of St. Michaels, adopted April 13, 1935, setting monetary compensation at Fifteen Dollars annually; and

WHEREAS, the demands, responsibilities and scope of town government have substantially increased, so that increasing demands are made upon the time of the Commissioners; and

WHEREAS, it is believed that more adequate compensation should be paid to the Commissioners for the time spent on Town business.

SECTION 1.

NOW, THEREFORE, BE IT ORDAINED BY THE COMMISSIONERS OF ST. MICHAELS, that the annual salary of each duly elected, chosen, appointed or otherwise qualified member of the Commissioners of St. Michaels shall be Four Thousand dollars (\$4,000.00), effective July 1, 2020, payable quarterly.

SECTION 2.

AND BE IT FURTHER ORDAINED AND ENACTED, that this ordinance shall take effect twenty (20) days from the date of its enactment, having been read at two (2) meetings of the Commissioners of St. Michaels and having been passed by a yea and nay vote of the Commissioners of St. Michaels.
