ORDINANCE NO. 446

AN ORDINANCE TO AMEND THE CODE OF THE TOWN OF ST. MICHAELS; CHAPTER (340), ARTICLE XV (DEFINITIONS), OF THE CODE OF THE TOWN OF ST. MICHAELS BY REPEALING AND REENACTING THE DEFINITION OF STRUCTURE; AND GENERALLY RELATING TO STRUCTURES IN THE TOWN OF ST. MICHAELS

WHEREAS, it is the desire of the Commissioners of the Town of St. Michaels (the "Commissioners") to amend Chapter 340 of the Code of the Town of St. Michaels by making textual changes to Section 108 "Definitions"; and

WHEREAS, the Commissioners have determined the textual changes to Chapter 340 do not require Planning Commission review; and

WHEREAS, all the requirements of the Annotated Code of Maryland (2012), as amended, and Article XII of Chapter 340 of the Code of the Town of St. Michaels, have been satisfied; and

WHEREAS, public notice was published on June 10, 2014 and June 17, 2014 that a public hearing would be held by the Commissioners on June 25, 2014 concerning amendments to Chapter 340 of the Code of the Town of St. Michaels substantially in the form as hereafter set forth; and

WHEREAS, after having given due public notice, the Commissioners conducted a public hearing on June 25, 2014 to receive public comment on the aforesaid amendments; and

WHEREAS, all the requirements of the Maryland Annotated Code, as amended, and Article XII of Chapter 340 of the Code of the Town of St. Michaels, have been satisfied; and

WHEREAS, for the reasons stated above the Commissioners deem it in the interest of the public health, welfare and safety of the citizens of the Town, and for the good government of the Town, to enact the following Ordinance.

<u>SECTION 1.</u> NOW, THEREFORE, BE IT ORDAINED AND ENACTED BY THE COMMISSIONERS OF ST. MICHAELS that Chapter 340 (Zoning), Article XV(Definitions), Section 108 (Definitions) of the Code of the Town of St. Michaels is hereby repealed and reenacted as follows, with new language shown in *italics* and <u>underlined</u> and deleted language shown in ((double parentheses)) and as a <u>strikethrough</u>:

STRUCTURE

((Building or construction materials, or a combination of those materials, that are purposely assembled or joined together on or over land or water. Structure includes a temporary or permanent fixed or floating pier, piling, deck, walkway, dwelling, building, boathouse, platform, gazebo or shelter for the purpose of marine access, navigation, working, eating, sleeping, or recreating))

STRUCTURE

Anything that is built or constructed, the use of which is intended to have a permanent location on the ground or is attached to or abuts something having a permanent location on the ground. The term "structure" shall be construed as if followed by the words, "or part thereof".

SECTION 2. AND BE IT FURTHER ORDAINED AND ENACTED, that this Ordinance shall take effect twenty (20) days from the date of its enactment, having been read at two (2) meetings of The Commissioners of St. Michaels and having been passed by a yea and nay vote of The Commissioners of St. Michaels.
