I. Call to Order

Present were Commissioners Bill Boos, Roy Myers, Jaime Windon, Joyce Harrod and Mike Bibb, Town Manager Jean Weisman, Zoning Officer Sarah Abel, Town Attorney Patrick Thomas, Legislative Clerk Suzanna Warnick, and several members of the public.

President Boos called to order the Legislative Meeting of the Commissioners of St. Michaels in the meeting room of the Edgar M. Bosley, Jr. Municipal Building, 300 Mill Street, St. Michaels, Maryland.

- **Public Hearing and Possible Vote - Resolution 2017-03**

President Boos opened the public hearing on Resolution 2017-03 a resolution for annexation of property, and called upon Mrs. Warnick, who read the resolution and exhibits into the record as follows:

RESOLUTION 2017-03, AN ANNEXATION RESOLUTION PURSUANT TO SECTION 4-401, ET SEQ. OF THE LOCAL GOVERNMENT ARTICLE OF THE MARYLAND ANNOTATED CODE FOR THE PURPOSE OF ANNEXING NINE PARCELS OF REAL PROPERTY CONSISTING OF 2.692 ACRES OF LAND, MORE OR LESS, LOCATED IN THE SECOND ELECTION DISTRICT OF TALBOT COUNTY, MARYLAND, ALONG THE WESTERN BOUNDARY OF THE TOWN, AND BEING MORE PARTICULARLY DESCRIBED HEREIN THE RESOLUTION; PROVIDING FOR THE TERMS OF SUCH ANNEXATION IN THE ANNEXATION PLAN AND AGREEMENT; AMENDING THE CHARTER OF THE TOWN OF ST. MICHAELS FOR THE PURPOSE OF INCLUDING THE ANNEXED PROPERTIES WITHIN THE LEGAL

DESCRIPTIONS AND PLATS DEPICTING THE CORPORATE LIMITS OF THE TOWN OF ST. MICHAELS; AND GENERALLY RELATING TO THE ANNEXATION OF THE FOREGOING PROPERTIES TO THE TOWN OF ST. MICHAELS

President Boos then asked for two Commissioners to bring Resolution 2017-03 forward for a public hearing. Commissioners Myers and Bibb brought the resolution forward. President Boos then called for comment from the Commissioners. Commissioner Harrod had suggestions for some grammatical clarifications. President Boos called upon Attorney Patrick Thomas, who provided an overview of the annexation and the process for the public. Wayne Suggs of Habitat Choptank said he was positive about the annexation moving forward, but asked why the Commissioners were not

voting on the annexation at this meeting. President Boos explained that the delay was due to having to follow the required legislative process for an annexation resolution. Commissioner Myers said that without any objections, the Commissioners would probably calendar the annexation for the next legislative meeting. Attorney Thomas explained the legislative process for annexation or charter resolutions must follow clear procedures for Steve Clineberg, an out-of-town resident. Mr. Clineberg said he favored the annexation and supported the work of Habitat Choptank. In order to accommodate Habitat Choptank's construction schedule, the Commissioners agreed to expedite the regulatory process by getting the agreement signed by all parties as soon as possible and to schedule a vote on the resolution for the October 4th Commissioners' meeting. After some additional discussion, President Boos closed the public hearing on Resolution 2017-03.

IV. Comments from the Commissioners

There were no additional comments.

V. Announcement of Future Meetings

The Commissioners made some adjustments and additions to their meetings in October 2017, and set a discussion of the hazard mitigation plan with the County for the November 8, 2017 Commissioners' meeting. It was noted that the Town offices would be closed on Monday, October 9th for Columbus Day and that the Commissioners' October 11, 2017 meeting would be held at the St. Michaels Library building on Fremont Street.

The meeting was adjourned at 6:30 p.m.
