ORDINANCE NO. 471

AN ORDINANCE TO AMEND CHAPTER 266 OF THE CODE OF THE TOWN OF ST. MICHAELS, ENTITLED ‘SKATEBOARDS, SKATES AND RECREATIONAL VEHICLES’; TO REMOVE §266-2 RESTRICTIONS, SUBPARAGRAPH D

WHEREAS The Commissioners of St. Michaels wish to recognize the need to address parking in the town; and

WHEREAS, The Commissioners of St. Michaels have passed on February 25 2016 Resolution 2016-03 - A RESOLUTION OF THE COMMISSIONERS OF ST. MICHAELS FOR THE PURPOSE OF REMOVING THE SKATEBOARD EQUIPMENT AND FENCING FROM THE SKATEBOARD PARK AT 301 MILL STREET TO PROVIDE FOR ADDITIONAL PARKING IN THE TOWN; and

WHEREAS, with the passage of Resolution 2016-03, the skateboard park at 301 Mill Street will be closed effective March 31, 2016, necessitating the removal of mention of said skateboard park from Chapter 266 of the Code of the Town of St. Michaels.

NOW, THEREFORE, BE IT RESOLVED:

SECTION I:

~~Chapter 266 §266-2. Restrictions. Subparagraph D.- Skateboarding and in-line skating only are allowed at the Town’s skateboard park, 301 Mill Street. All activity at the skateboard park must be in compliance with the rules of the park as approved by the Commissioners and amended from time to time.~~


Re-number existing §266-2 E. to become §266-2 D.
Re-number existing §266-2 F. to become §266-2 E.

SECTION II:

AND BE IT FURTHER ORDAINED AND ENACTED, that this Ordinance shall take effect twenty (20) days from the date of its enactment, having been read at two (2) meetings of The Commissioners of St. Michaels and having been passed by a yea and nay vote of The Commissioners of St. Michaels.





