**RESOLUTION 2019-04**

**A RESOLUTION OF THE COMMISSIONERS OF ST. MICHAELS TO ALLOW THE INSTALLATION OF ‘MUNICIPAL SLIP HOLDERS ONLY MAY – OCTOBER’ SIGNS ALONG THE BULKHEAD ON WEST HARBOR ROAD; EVERY THIRD PARKING SPACE FROM SLIP #19 AT THE SOUTH BOAT RAMP, TO SLIP #43 AT THE CORNER OF WEST HARBOR ROAD AND EAST CHEW AVENUE**

WHEREAS, THE ST. MICHAELS CODE, Chapter 312, Vehicles and Parking, §312-2, allows the Commissioners by resolution to establish and/or eliminate designated areas in the Town where stopping, standing and/or parking of vehicles is prohibited by an official sign; and

WHEREAS, the St. Michaels Waterway Management Advisory Board, in support of our local watermen and municipal slip holders has recommended the placement of “Municipal Slip Holders Only May - October” signs to be placed at every third parking space along the Town’s bulkhead from the South Boat Ramp, along West Harbor Road South, to East Chew Avenue; and

WHEREAS, the Commissioners of St. Michaels recognize the importance of supporting both our local watermen and municipal slip holders and to provide them with reasonable access to their boat slips; and

WHEREAS, at their meeting on September 10, 2019, the Commissioners did consider the recommendation of the St. Michaels Waterway Advisory Board to install “Municipal Slip Holders Only May – October” signs to be placed at every third parking space along the Town’s bulkhead from the South Boat Ramp, along West Harbor Road South, to East Chew Avenue.

NOW, THEREFORE, BE IT RESOLVED, that upon the passage of this Resolution by a majority of The Commissioners of St. Michaels, “Municipal Slip Holders Only May - October” signs will be erected at the above stated location.
