I hereby declare or affirm, under the penalties for perjury, that I meet the qualifications as required by Article II, Section §C-6 and Article IV, Section §30 of the St. Michaels Charter as a part of the St. Michaels Code to register as a candidate for the office of Commissioner, in that:

1. I am a registered voter of the Town of St. Michaels as defined by the St. Michaels Charter as part of the St. Michaels Code; and as of the date of the election I will meet all of the qualifications required by the Charter for a registered voter of the Town; and
2. I understand that my principal residential address must be within the corporate boundaries of the Town during my term of office; and
3. My principal residential address has been within the corporate boundaries of the Town of St. Michaels for at least two (2) consecutive years immediately preceding the above stated election date, at the following addresses:

I understand that the term expiring in June 2022 goes to the winning candidate with the least number of votes.
